Congratulations on your purchase of the LED Attachment II This manual will provide an overview of the LED Attachment II's functions, capabilities, and instructions for proper operation. If you have questions outside the scope of this manual, feel free to contact us directly.

### **OVERVIEW**

The Club Cannon LED Attachment II is a accessory designed for use with the Club Cannon DMX Jet MKII and the Club Cannon Pro Jet.

The LED Attachment II is a powerful and versatile lighting fixture designed for ease of use and dynamic performance. Its quick attachment design simplifies installation, saving time and effort. The fixture supports multi-zone control, allowing operators to create complex and layered lighting effects. With DMX control, it offers wide compatibility and can be easily integrated into existing DMX systems. The addition of Remote Device Management (RDM) functionality facilitates remote operation and maintenance of the device.

The LED Attachment II utilizes high-power 20W LEDs that support Red, Green, Blue, White, Amber, and UV color ranges. This wide color range, combined with the device's support for multiple operating modes from 2 to 14 DMX channels, offers an impressive level of control and flexibility. The 10-degree beam angle is perfect for delivering focused and intense lighting on the CO2 plume.

Secure and reliable power connections are ensured through the use of Neutrik True1 connectors for power input and output. For improved setup cleanliness and easier cable management, the power and DMX ports are conveniently located on the bottom of the device.



# SAFETY GUIDE



To ensure safe operation, user must follow instructions closely. Necessary protocols should be followed when handling and operating Special Effects Equipment and their respective consumables.

#### When using the products, always follow the safety radius displayed in this manual.

Once the product is attached to the  $CO_2$  tanks and the tanks are turned on, the product, hoses and fittings will be under high pressure. Do not disconnect any fittings or hoses until the tank has been turned off, and the remaining gas has been cleared through the product, depleting all pressure in the system. If a leak is detected, cease use of the product immediately. Never stand directly over unit while under pressure. Jets should be mounted or fixed in a safe place. When using Jets above ground, always use a safety cable in the event the Product's mount or fixture should fail. You must supply the safety cable(s) to use with this product. If you are under 18, you should not be using this product.

CO<sub>2</sub> Special Effects are to only to be used in well ventilated areas. Failure to do so may result in oxygen displacement.

## QUICK START DMX GUIDE



### **1.** Mount LED Attachment II

Slide the LED Attachment II over the barrel, making sure the sponge is sliding without catching. Be careful to not have fingers under magnets. True1 and DMX jumpers have been included for clean cabling to and from the fixture.



### 2. Boot LED Attachment II

The LED Attachment II AC power through the TRUE1 connector on the bottom of the product. The LED Attachment features an auto-switching power supply and accepts 110-240v AC.



#### 3. Set DMX Addresses


The LED Attachment II is preaddressed to channel 2 in Extended Mode (9ch). This allow the fixture to work out of the box with Club Cannon DMX Controllers. Jet should be addressed to channel 1 for proper operation.




The last step is to attach a DMX controller like "The Button", "ShoStarter" or "ShoMaster" to control the Pro Jet and LED Attachment. The illuminated decimal point on the fixtures indicates that the unit(s) are receiving a DMX signal.

## MENU SCREEN


This unit features quick access to setting the DMX address. This is the default screen that is shown when the LED Attachment II is first powered on.



### DMX ADDRESSING




When the LED Attachment II is receiveing DMX the unit will enter a lockout state. Fixture can be unlocked by removing DMX, or holding down any button for 5 seconds. This will unlock the system menu for reconfiguration.



When addressing the LED Attachment, press "enter" to store address, or "menu" to cancel. If the unit is receiving DMX it will re-enter its lockout state after 30 seconds.

## MENU SCREEN



### ADDRESS

Depending on selected mode, DMX address can be set between 1-510.

## The LED Attachment II supports five modes of operation:

2-Channel Mode (Simple)
5-Channel Mode (Basic)
8-Channel Mode (Raw)
9-Channel Mode (Extended)
14-Channel Mode (Tour)

The mode can be selected by setting the personality from display or via RDM. Each mode interprets DMX input data in a different way, allowing for different levels of control over the LED's color and brightness.

The LED Attachment II supports various macro commands, such as setting a specific color or creating a color fade or jump see table of following page for more info.


The LED Attachment MKII supports strobe effects, which can be controlled using the strobe variable in the 5-channel, 8-channel, 9-channel, and 14-channel modes. The strobe frequency can be adjusted from 0.5hz Hz to 20 Hz.

## DMX MODES

### LED ZONES

The LED Attachment introduces a dual-zone control system in its 14-channel "TOUR" mode. This allows users to independently illuminate the front and back of the CO2 plume. Led zones are separated as seen below.

Display Blank or Odd Charaters	<ul><li>Reboot via power cycle.</li><li>If issue persists, contact Club Cannon directly.</li></ul>
Unit Resetting While Triggering	<ul><li>Make sure power supply is properly grounded.</li><li>If no earth ground is present, cease use immediately.</li></ul>
Unit Does Not Power On	<ul> <li>Ensure correct voltage is being supplied to product.</li> <li>Supplying incorrect voltage will cause permanent damage.</li> <li>If issue persists, contact Club Cannon directly.</li> </ul>
